

# **COOKIE POLICY**

This version of Cookie Policy was updated on 21st of February 2022

Each time You visit ABS Website [https://abs-imoney.co], information regarding Your access and usage, as well as Your data, is collected using various data harvesting tools or by third parties acting on behalf of ABS to help Us make Our Website useful, convenient, effective, secure and to serve You better by using relevant technologies.

## WHAT IS A COOKIE?

Websites in order to work smoothly need to collect certain basic information about their Users. Therefore, Websites rely on cookies – small text files – that are placed on Users' computers and stored by Users' Internet browser. Cookies contain basic information about Your Internet usage. Your browser sends these cookies back to Our Website every time You revisit it, so it can recognise Your computer or mobile device and make Your session on the Website convenient.

Cookies perform various functions and generally contribute making the usage of the internet smoother and more interactive. For instance, cookies are used to save Users' preferences on the often-visited sites, to remember User ID, and to help navigating between pages more efficiently.

This Website uses different types of cookies. Some cookies are placed by third party services that appear on our pages. You can at any time change or withdraw Your consent.

### **HOW DOES ABS USE COOKIES?**

Some cookies are associated with Your account and personal information in order to remember that You are logged in. Other cookies are not tied to Your account but are unique and allow Us to carry out analytics and customization, among other similar things. Cookies can be used to recognize You when You visit a Website or use Our Services, remember Your preferences, and make Your Website session convenient. Cookies also make Your interactions faster and more secure.

We use both persistent and session cookies, as well as their varieties for the operation of the Website:

**Essential cookies:** necessary for the normal functioning of the Website. The Company may use essential cookies to authenticate Users, prevent fraudulent use of accounts, or provide certain features of the Site.

**Analytics and performance cookies:** to provide Our products to Users and improve the quality of interaction, We use cookies and other identifiers to collect data about Site usage and performance.

**Functional cookies:** this type of cookies is used to recognise repeat visits to the Website. Allow the contents of the Website to be personalised for Users and save selected settings (e.g. language, login and password, etc.).

## **COOKIE PREFERENCE MANAGEMENT**

Your personal preferences regarding which of Your personal data is collected are of the utmost importance to Us when You are using Our Website. However, preference management is not possible for cookies that are necessary for the Website to operate. Please also note that, in the event that some cookies are closed, various features of the Website may be unavailable.

## Information on how to manage the cookie preferences is as follows:

You have the right to personalize Your preferences by changing the browser settings You view on our Website. If the browser You are using offers this option, it is possible to change the preferences for cookies through Your browser settings. Although it may be changed according to the options that the browser offers, this means that data owners may be able to prevent the use of cookies, to receive a warning before cookies are used, or just to

disable or delete some cookies. The preferences for this topic vary depending on the browser You use. Your preferences for cookies may need to be selected separately for each device on which You access Our website.

#### THIRD-PARTY COOKIES

We may employ third-party companies and individuals on Our Websites – for example, analytics providers and content partners. We grant these third parties access to selected information to perform specific tasks on Our behalf. They may also set third-party cookies in order to deliver the services they are providing. Third-party cookies can be used to track You on other websites that use the same third-party service. As We have no control over third-party cookies, they are not covered by this Cookie Policy.

#### **USER RIGHTS**

Please note that all cookies cannot be disabled in our preference center, because they are strictly necessary to use some of the Website's functions. Because these cookies are essential to delivering Our Services safely, You cannot refuse them and expect the Website to work in a proper way.

## The User has a right to remove cookies from his/her device

You can delete all cookies that are already on Your device by clearing the browsing history of Your browser. This will remove all cookies from all websites You have visited.

If You do not wish to accept cookies from Us, You can instruct Your browser to refuse cookies from Our Website. Most browsers are configured to accept cookies by default, but You can update these settings to either refuse cookies altogether, or to notify You when a Website is trying to set or update a cookie.

We inform You that due to clearing the browser You may also lose some saved information (e.g. saved login and password details, website preferences, etc.).

## The User have a right to manage Website-specific cookies

For more detailed control over Website-specific cookies, check the privacy and cookie settings in Your preferred browser.

# The User have a right to block cookies

You can set most modern browsers to prevent any cookies being placed on Your device, but You may then have to manually adjust some preferences every time You visit any Website page. And some Website functionalities may not work properly (e.g. profile logging-in).

## **COOKIE POLICY AMENDMENT**

This Policy may be revised, changed, updated and / or amended at any time without prior notice at the ABS sole discretion. The date when this Policy was updated will be displayed on the first page of the Policy. We strongly recommend that Users check the Cookie Policy on a regular basis for changes. Each User agrees that it is his/her own responsibility to review from time to time the current version of this Cookie Policy.
